- Built a strategy and structure for reimagining Trinity's philanthropic giving, growing grants from \$8 million per year to \$57 million per year in four years, and building a new team of 25.
- Developed principles and guidelines for a new \$100 million impact investing fund from Trinity's endowment, focused on affordable housing and racial justice. Supported the development of 5,500 units of affordable housing.
- Fundraised over \$3.5 million from other foundations to add to Trinity's grants budget.
- Established an \$8 million loan fund to help nonprofit grantees respond to COVID-19 with two-thirds of the 15 organizations funded led by people of color.
- Worked closely with Chair of the Vestry Grants Committee to make significant governance changes to reduce bureaucracy and better support grantees, including a new structure for multi-year grants and appropriate delegation of authority.
- Imagined and implemented a new "walking alongside" offering for grantees, including capacity building, financial technical assistance for thirty grantees, marketing support, and leveraging Trinity's influence and voice.
